IDENTIFICATION

PROOF OF INCOME

- c. Currently Unemployed
 - i. You must include copies of unemployment earnings and/or proof of assistance/benefits for the past 30 days, or a written statement from at least one public welfare agency showing income for the past 12 months.
 - ii. If you claim no income, a statement of support from the individual providing the support is required.
- d. Retired
 - i. You must include copies of all sources of income, government or otherwise.

HOUSEHOLD SIZE
